Introduction

July marked the tenth month of our third year of operations and it included the final disbursements of the 2022 season. The inaugural Jason Fritz Memorial Scholarship was awarded to Karlin Weisinger, the drum major for Gold, while our final tuition payment to our student marching with Carolina Crown cleared the bank during August. The fund recorded \$518.00 in net losses for the month for expenses paid that did not have any offsetting donations. To date, the Jason Fritz Memorial Endowment has a \$500 spendable balance (following the release of funds for the 2022 scholarship) and a \$13,734.95 permanently restricted balance whose investment earnings will be used to support future scholarships.

With the 2022 season ending next week, the scholarship fund has officially closed the 2022 season with \$5,935.00 awarded to 16 students across nine different corps. Our general scholarship program supported 15 students while the Jason Fritz Memorial Scholarship sponsored one student. Our students in the world class circuit performed with the Blue Stars, Cadets, Carolina Crown, Colts, Phantom Regiment, and the Troopers while those in the open class circuit marched with 7th Regiment, Legends, and Gold. They represent some of the best-of-the-best that our state (and the activity) has to offer and we look forward to hearing their updates in the coming months!

The Board would like to thank our donors once again for their support! Your willingness to give has provided sixteen students the opportunity to tour with a drum corps this summer and to bring the collective life lessons and musical expertise it brings back home to their communities. These students are spread across the state – from Marquette in the Upper Peninsula to Battle Creek where the scholarship fund was founded – and the potential number of future students influenced by your support today is immeasurable.

Financial Narrative

Cash for the month is \$518.00 lower than June for the net loss experienced during the month. Note that the \$500 Jason Fritz Memorial Scholarship was offset by the spendable endowment funds transfer that was made during June. \$205 of the total cash on hand is restricted to maintain minimum reserve requirements and \$1,099 is restricted for the Jason Fritz Memorial Endowment for donations to be transferred to BCCF.

Program related expenses are up \$500 for sponsorships made during the month while administrative expenses are up \$18.00 for the monthly Digital Ocean invoice and the annual website domain name renewal invoice from Google.

Restricted funds for the Jason Fritz Memorial Endowment are broken down as follows: \$13,734.95 is permanently restricted as the corpus of the endowment and \$500 remains invested as an opening spendable balance. Endowment earnings and losses are listed under the Investments category of the profit and loss statement with a -5.5% investment return based on our last quarterly statement. All unused funds at the end of this fiscal year will be reinvested in the corpus of the endowment. All funds are managed in accordance with Generally Accepted Accounting Principles in the United States.
